2. The Council shall comprise of the following senior and seasoned Members of the House:



3. The ToRs of the "Council senior Parliamentarians" shall be:

- i. To promote established conventions of mutual respect across the parliamentary divide.
- ii. To encourage young and first-time elected Members in understanding the good parliamentary practices, hence improving the quality of debate in the House.
- iii. To encourage issue-based discussion rather than mud-slinging and cross-accusation.
- iv. To prevent any untoward incident in the House or within the precincts of the National Assembly.
- v. To ensure upholding of democratic values especially ensuring respect and adherence to the Chair and its rulings despite all differences.
- vi. To avoid any sexist, religious, racial and ethnic comment or slogan on the floor of the House.
- vii. To assist and advise the Chair in implementing the above.
- viii. The Hon. Speaker may consult the Council on any other issue, as he may deem fit.
- ix. The Council may add any other item with mutual consensus.

4. The Legislation Wing of the National Assembly Secretariat shall act as the Secretariat of the Council.
