LEAVE APPLICATIONS

The leave applications of the Members who requested for grant of leave were read out by the honourable Speaker and granted.

FATEHA

The House offered *Fateha* for the departed souls of 12 persons who were martyred in the terror attacks on the Parliament of the Islamic Republic of Iran and the mausoleum of Ayatollah Khomeini.

RESOLUTION PASSED

Mr. Zahid Hamid, Minister for Law and Justice moved the following resolution, which was unanimously passed by the National Assembly:-

“The National Assembly of Pakistan strongly condemns terror attacks on the Parliament of the Islamic Republic of Iran and the mausoleum of Ayatollah Khomeini. This House expresses its solidarity with the people and Parliament of our brotherly neighbor Iran and reiterates its resolve to jointly combat the menace of terrorism with our neighbours in the region. This enjoys the unanimous support of all parties presenting in this august House.”

MOTION

Shaikh Aftab Ahmed, Minister for Parliamentary Affairs moved the following motion which was adopted by the House:-

“That under rule 288 of the Rules of Procedure and Conduct of Business in the National Assembly, 2007 the requirements of rules 51, 55, 57 and 158 of the said Rules in respect of Private Members Business, Ballot of Private Members’ Resolutions, Orders of the Day and Notice of resolution for today, may be suspended in order to take up a resolution.”

RESOLUTION PASSED

Mr. Aftab Ahmed Khan Sherpao, MNA moved the following resolution, which was unanimously passed by the National Assembly:-

“The National Assembly of Pakistan expresses its deep concern over recent developments in relations involving brotherly Muslim states in the Gulf region, including the Kingdom of Saudi Arabia and Qatar. This House calls upon all countries to show restraint and resolve all differences through dialogue. This House also calls upon the Government to take concrete steps towards forging unity amongst the Muslim Ummah in the region, in accordance with Parliament’s unanimous resolutions dated 10-04-2015.”
