BILL

further to amend the Code of Criminal Procedure, 1898, (Act No. V of 1898).

WHEREAS it is expedient further to amend the Criminal Procedure, 1898 for the purpose hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**- (1) This Act may be called the Code of Criminal Procedure (Amendment) Act, 2015.

(2) It shall come into force at once.

2. **Amendment of the schedule II in Section 365-A of the Code of Criminal Procedure (Act No. V of 1898).**- In the Code of Criminal Procedure Act (No. V of 1898), in schedule II, in section 365-A, in column 6, for the word "not compoundable", the words "compoundable with the permission of the Court", shall be substituted.

STATEMENT OF OBJECTS AND REASONS

Since backdrop of some criminal cases is personal vendetta or stand registered some dispute among the parties which some time results into conviction and there is no way out with the parties to reconcile the matters. Therefore, it seems very important to avoid undue litigation and punishment. This part of the schedule is amended as stated above.

2. This Bill seeks to achieve the above objectives.
