BILL

further to amended the National Database and Registration Authority Ordinance, 2000

Whereas it is expedient further to amend the National Database and Registration Authority Ordinance, 2000 (No. VIII of 2000) for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**-(1) This Act may be called the National Database and Registration Authority (Amendment) Act, 2014.
(2) It shall come into force at once.
2. **Amendment of section 8, Ordinance VIII of 2000.**- In the National Database & Registration Authority Ordinance, 2000, (No. VIII of 2000), hereinafter referred to as the said Ordinance, in section 8, for the words “fee of their sum to be charged therefore” the words “free of cost”, shall be substituted.
(2). **Amendment of section 10, Ordinance VIII of 2000.**- In the said Ordinance, in section 10, for the words “upon payment of such fee” the words “ free of cost”, shall be substituted.
- (3). **Amendment of section 11, Ordinance VIII of 2000.**- In the said Ordinance, in section 11, for the words “upon payment of such fee” the words “ free of cost”, shall be substituted.
- (4). **Amendment of section 12, Ordinance VIII of 2000.**- In the said Ordinance, in section 12, for the words “upon payment of such fee” the words “ free of cost”, shall be substituted.

STATEMENT OF OBJECTS AND REASONS

1. Since this House has unanimously passed the resolution on 04-03-2014 to the effect that National Identity Cards be provided to the citizens free of cost in the country, therefore the proposed amendments have become indispensable.
2. This Bill seeks to achieve the above-said objectives.
