 - iii) Recommendation of the Standing Committee dated 28th February 2020 whereby it was recommended that "the Government should confiscate all blasphemous books from the market and strict action may be taken against the printers, the importers and the sellers of the books. Ministry of Religious Affairs and Inter-Faith Harmony shall coordinate with all relevant quarters, including the Prime Minister's office, Interior Division, Provincial Governments, the ICT administration, the Governments of Azad Kashmir and Gilgit-Baltistan, in this regard."

 - v. Consideration of PSDP, 2021-22;
 - vi. Consideration of Report of Sub-Committee;
