 - 3) Briefing by Ministry of Foreign Affairs on the following questions raised by Engineer Khurram Dastgir Khan, MNA/Member:
 - a) Prime Minister's remarks in Kotli, AJ&K on 5th February, 2021 in which he said the following:

“When the residents of Indian-occupied Kashmir as well as Azad Kashmir get the right to decide their future, and when the people of Kashmir will choose Pakistan *InshAllah*, then Pakistan will give Kashmiris the right to decide whether they want to become a part of Pakistan or remain independent.”
 - b) Restoration of Line-of-Control ceasefire announced on 25th February, 2021 in context of Prime Minister's earlier assertions that:

“India was backing the militant Islamic State (IS) group to cause turmoil in Pakistan”
“No talks possible with India until they restore the autonomous status” of Jammu and Kashmir.
 - 4) Briefing by Ministry of Information & Broadcasting and Pakistan Electronic Media Regulatory Authority (PEMRA) for special coverage given to highlight the Kashmir cause on electronic media for awareness of public at large regarding Kashmir conflict. **Representatives of All Public, Private media outlets to attend and also brief the Committee on the same;**
 - 5) Briefing by Chairman, Pakistan Telecommunication Authority on measures taken by the authority to end blockade of Kashmiri content by Facebook management. The regional representative of Facebook to be invited online to explain the Committee about censorship policy of Facebook;
 - 6) Any other item with the permission of the Chair
