- 6) *PIMS being the largest public hospital of Islamabad, what is its Accessibility Status? And what are the special facilities provided to the PWDs in PIMS, in case of emergency as NIRM does not caters the emergency cases?*
- 7) *According to the brief provided by the Ministry of National Health Services, Regulations and Coordination only 04 PWDs are currently employed, why 02 % quota is not observed as per policy in vogue and according to the directions of the Supreme Court of Pakistan. What efforts are made in that regard?*
- 8) *Whether the Budget allocated to NIRM is found sufficient for catering the needs of PWDs?*
- 9) *NIRM to provide complete detail of the PWDs treated this year.*
- 10) *Total PWDs that benefited from Sehat Sahulat Program this year? If there is any number, complete detail to be provided.*
- 11) *Sehat Sahulat Program to provide the total number of PWDs registered with the NADRA, families registered and PWDs facilitated.*
- 12) *What is the exact figure of payment made by the Federal Government to the PWDs since inception of SSP; and*
- 13) *Any other Item with the permission of the Chair.*
