- 4) Briefing by the Chairman Federal Board of Revenue (FBR), regarding overall performance of FBR and particularly about refunds on both income tax and sales tax from 2008, till date;
- 5) To discuss the issue being faced by the employees of the Universities of the Punjab regarding the release Disparity Special Allowance DRA 25% by Finance Department government of Punjab **announced by the Federal Government on basic pay BS 1 to 19;**
- 6) To discuss the issues noted during the visit of the Parliamentary delegation to Azerbaijan headed by the Hon. Speaker regarding Finance sector i.e: -

*"Prolonged and cumbersome due diligence by Pakistani banks over use of Iran (Tajistan border) as transit country, above and beyond AML requirements set by the State Bank of Pakistan SBP). In many instances, documents have to be changed showing other Central Asian Countries as destination instead of Azerbaijan to get E-Forms from Banks. These practices adversely impact the appetite to conduct trade between Pakistan and Azerbaijan. The situation needs serious mitigation. Select commercial banks may be asked to do away with these onerous requirements."*

- 7) To discuss the issues being faced by Pakistan National Building Material Display Center Foundation (PNBMDCF) (Non-Profit Organization) regarding **tax exemptions by the (FBR)**, as already granted to various other organization on similar grounds; and
- 8) Any other item with permission of the Chair.
