#### **LEGISLATIVE BUSINESS**

2. **MR. SHAHID KHAQAN ABBASI**, Minister for Petroleum and Natural Resources to move that the Bill to provide for prosecution of cases of gas theft and other offences relating to gas and to provide a procedure for recovery of amounts due [The Gas (Theft Control and Recovery) Bill, 2014], as passed by the Senate and not passed by the National Assembly within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution.

3. **MR. 6. **SENATOR GHOUS MUHAMMAD KHAN NIAZI** to move that the Bill further to amend the Emigration Ordinance, 1979 [The Emigration (Amendment) Bill, 2014], as passed by the Senate and not passed by the National Assembly within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution.

7. **SENATOR GHOUS MUHAMMAD KHAN NIAZI** to move that the Bill further to amend the Emigration Ordinance, 1979 [The Emigration (Amendment) Bill, 2014], be passed.

8. **SENATOR SAEED GHANI** to move that the Bill further to amend the Civil Servants Act, 1973 [The Civil Servants (Amendment) Bill, 2014], as passed by the Senate and not passed by the National Assembly within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution.

9. **SENATOR SAEED GHANI** to move that the Bill further to amend the Civil Servants Act, 1973 [The Civil Servants (Amendment) Bill, 2014], be passed.

SENATOR FARHATULLAH BABAR** to move that the Bill further to amend the Pakistan Penal Code, 1860 and the Code of Criminal Procedure, 1898 [The Anti-Honour Killing Laws (Criminal Laws Amendment) Bill, 2015], as passed by the Senate and not passed by the National Assembly within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution.

**13. SENATOR FARHATULLAH BABAR** to move that the Bill further to amend the Pakistan Penal Code, 1860 and the Code of Criminal Procedure, 1898 [The Anti-Honour Killing Laws (Criminal Laws Amendment) Bill, 2015], be passed.

**14. SENATOR FARHATULLAH BABAR** to move that the Bill further to amend the Privatization Commission Ordinance, 2000 [The Privatization Commission (Second Amendment) Bill, 2015], as passed by the Senate and not passed by the National Assembly within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution.

**15. SENATOR FARHATULLAH BABAR** to move that the Bill further to amend the Privatization Commission Ordinance, 2000 [The Privatization Commission (Second Amendment) Bill, 2015], be passed.
