This corrigendum is issued to clarify and rectify certain details in the above-mentioned tender notice published in daily Nawa-i-Waqt and the Express Tribune Islamabad on 17<sup>th</sup> & 18<sup>th</sup> July, 2025 respectively and Tender Published on PPRA website on 17<sup>th</sup> July, 2025 **Ref. No. TS605793E**. Please note the following changes and clarifications:

The National Assembly Secretariat, Islamabad, invites bids through E-PADS from eligible, experienced, and financially sound firms/tailors for **preparation of official summer uniforms**, as and when required, up to **June 30, 2026**. Samples of these uniforms may be inspected during office hours at the office of the undersigned. Proposals are solicited through the **"Single-Stage Two Envelopes" Bidding Procedure under Rule 36(b) of the Public Procurement Rules, 2004**. Firms eligible to apply must be registered with the relevant authorities, including the Income Tax and Sales Tax Departments of FBR (NTN & GST etc.), listed on the Active Taxpayer List (ATL), possess a minimum of five (5) years of relevant experience, not blacklisted by any government entity and demonstrate ownership of their own workforce (Proof of Salary required). A **Tender Security of PKR 500,000/-** in the form of a bank draft/CDR (refundable) in favour of the Section Officer (Procurement), National Assembly Secretariat, must be attached with the Technical Proposal. Bidders providing unsubstantiated and/or incorrect information are liable to legal action and/or disqualification/blacklisting in accordance with the rules *ibid*. The rates quoted in the financial proposal shall remain valid up to **June 30, 2026**. The Procuring Agency reserves the right to accept/reject any or all proposals, increase/decrease quantities, or cancel the tender as per PPRA rules.
