PROCUREMENT OF MINERAL WATER

(E-Procurement of Services)

Sealed bids are invited on Single Stage – Two envelope procedure from the reputable authorized distributors duly approved from Pakistan Standards and Quality Control Authority for supply of drinking mineral water at Parliament House, Islamabad.

TERMS AND CONDITIONS: -

- (i) Only Islamabad / Rawalpindi based firms and authorized distributors on Active Taxpayers List (ATL) of FBR, having valid GST, NTN and vendor number are eligible to apply;
- (ii) The bidder must have valid license of Pakistan Standards and Quality Control Authority for sale and supply of drinking water;
- (iii) The bidder has not been black listed;
- (iv) The bidder Bank Statement must be attached;
- (v) The bidder must be registered from ISO and having at least 10 years experience for supply of mineral water;
- (vi) The bidder providing all items, will be given preference;
- (vii) The bidder has packing of water bottles according to ISO.
- (viii) National Assembly Secretariat reserves the right to accept / reject wholly or partially any proposal or cancel tender altogether at any stage under provision of PPRA rules;
- (ix) The tender is initially for one year, extendable for further one year subject to satisfactory services.

2. The bidding documents, containing detailed terms & conditions, bid evaluation forms may be obtained, free of cost from the office of the undersigned located at Parliament House, Islamabad during office hours. Tender Notice & Tender Document can also be downloaded from the websites of National Assembly Secretariat (www.na.gov.pk) and PPRA (www.ppra.org.pk).

3. The bids must reach the office of the undersigned on or before 17th March, 2025, at 11.00 a.m., only technical bids will be opened on the same day at 11:30 a.m.



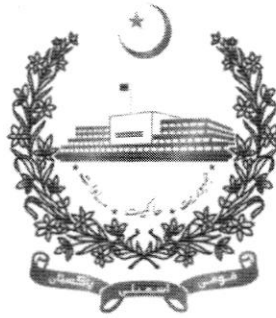

A. TERMS AND CONDITIONS OF TENDER FOR SUPPLY OF DRINKING MINERAL WATER BOTTLES:-

BIDDING PROCEDURE:-

As per Rule 36(b) of PPRA Rules, 2004, Single Stage-Two Envelope Bidding Procedure shall be followed. The bidders are required to submit their bids in single package containing two separate envelopes marked as "Technical Proposals" and Financial Proposals" in bold and legible letters. Initially, envelope marked as "Technical Proposal" will be opened on 17th March, 2025, at 11:30 a.m., in presence of the Bidders.

After evaluation of "Technical Proposals" as per criteria at Para B, the "Financial Proposal" of only technically qualified bidder(s) shall be opened in the presence of bidders after informing them telephonically regarding time and date of opening of their financial bids. The Financial Proposals of the firms found technically non-responsive shall be returned un-opened to the respective bidder.

SECURITY (EARNEST MONEY):-

The Bidders must furnish the bid security for a sum Rs.50,000/- in the form of Pay Order / Bank Draft / Call Deposit Receipt in the name of Section Office (Procurement), National Assembly Secretariat and will place the same with Technical proposals. The bid without earnest money shall be rejected. Earnest money of successful firm will be retained as service guarantee. The earnest money of financially unsuccessful bidders will be returned after award of contract to the successful firm. The Service guarantee will be returned to the successful firm on expiry of contract. The quoted price should be in Pak Rupees, fixed and valid for whole one year. Inclusive of all taxes, duties, levies, insurance, freight etc., Inclusive of all charges up to the delivery point i.e. Parliament House, Islamabad;

TENDER VALIDITY:-

90 days from the date of submission of the Tender;



GENERAL INSTRUCTIONS TO BIDDERS:-

1. Only Islamabad / Rawalpindi based firms and authorized distributors who are on Active Tax Payers list (ATL) of FBR and have valid GST/NTN/Vender number are eligible to apply;
2. Bidders should be based in Islamabad / Rawalpindi or must have a regional office / Ware House in Islamabad / Rawalpindi;
3. Bidders must have valid license of Pakistan Standards and Quality Control Authority for sale and supply of drinking water plastic bottles;
4. The standard of drinking water must be according to the parameters adopted by PCRWR & PSQCA;
5. Firms black listed during last five years are not eligible. An affidavit of non-blacklisting on Rs.100 stamp paper will be provided by the firm;
6. Technical and Financial Evaluation will be done as per procedure laid down at para "B" and "C" of the Tender document;
7. Prices mentioned in tender must include GST and all other applicable taxes otherwise, tender shall be rejected;
8. The bidder must be registered from ISO and having at least 10 years experience for supply of mineral water;
9. Preference will be given to those firm who provides all items, as the National Assembly Secretariat is located in the Red Zone area movement of private/supply vehicles required security clearance from Ministry of Interior;
10. The bidder must have water quality equal to Nestle company;
11. The bidder must have packing of water bottles according to ISO;
12. Bidders are required to prepare their proposal carefully. Any correction, alteration, overwriting will not be acceptable. Each page / document must be signed, numbered, stamped and sealed properly;
13. Incomplete, conditional and bids received after due date and time will not be considered;
14. National Assembly Secretariat reserves right to increase / decrease the quantity or accept / reject wholly or partially any proposal or cancel tender altogether at any stage under PPRA rules;
15. Bids must reach Section Officer (Procurement), National Assembly Secretariat, Parliament House, Islamabad, till 11.00 a.m., on 17th March, 2025. The Technical Bids of the tender will be opened by the National Assembly Secretariat Purchase Committee on the same date at 11:30 a.m.;
16. In case the date of opening is declared public holiday or non-working by the government, the next official working day shall be deemed to be the date of opening of tender. The time and venue will remain the same;
17. The firms who want to attend tender opening shall inform in writing the name of owner / representative to the Section Officer (Procurement) on due date before 10.00 a.m., on telephone No.9103214 for issuance of entry passes;

BID EVALUATION CRITERIA

B. TECHNICAL PROPOSAL EVALUATION:-

Following information / documents are required for Technical Evaluation:-

S.No.	Mandatory Requirement
i.	Bid Form on bidders letter head duly signed & stamped as per sample attached at Annex-I ;
ii.	Firm Registration Certificate or in case of distributor an authorization letter as issued by relevant Authority;
iii.	Copy of Certificate of Pakistan Standards and Quality Control Authority (PSQCA) for sale / supply of drinking water;
iv.	Sale Tax Registration Certificate;
v.	Valid National Tax Number (NTN) Certificate;
vi.	Proof of Active Tax Payer List;
vii.	List of Client with copies of work order / agreement as a proof of relevant experience of at least 10 years as per sample attached at Annex-II ;
viii.	Preference will be given to those firm who provides all items due to accessibility and security reason as the premises located in the Red Zone/high Security area.
ix.	The bidder must be registered from ISO and having at least 10 years or more experience for supply of mineral water;
x.	The bidder must have packing of water bottles according to ISO;
xi.	An affidavit on stamp paper of Rs.100/- that the firm has neither been blacklisted in past five years by any Ministry / Division / Department / Organization of Government of Pakistan nor involved in any litigation as per sample attached at Annex-IV ;
xii.	Bidder Bank statement of last financial year;

Note:- Verifiable documentary proofs for all above Documents are mandatory;

1. The Technical Proposal must contain all above mentioned mandatory documents, otherwise bid will be rejected;
2. The bidders who have duly complied with Technical Proposal Evaluation Criteria will be eligible for further processing. The Members / Nominees of Purchase Committee will visit their office / Plant / warehouse on given addresses to physically check the status of their plant / office / warehouse, equipment, hygiene, automatic processing system, manpower as well as assess their ability to meet the requirement / demand of National Assembly Secretariat. The visit Report shall form part of technical evaluation;
3. The Purchase Committee will evaluate the visit report and thereafter make final recommendations for opening of Financial Proposals of technically qualified bidders;

FINANCIAL BID EVALUATION CRITERIA:-

- (i) On the recommendation of the National Assembly Purchase Committee, the Financial Proposals of only Technically qualified bidders will be opened on the date and time to be shared telephonically with qualified bidders;
- (ii) Bidders are required to prepare their financial bids carefully on their letter head as per sample attached at **Annex-III**. In case of any correction / alteration / overwriting, the financial bid will be rejected;
- (iii) The price quoted should be inclusive of all applicable taxes, duties and charges;



D. AWARD OF BID

(i) The bid will be awarded to most advantageous bidder i.e., technically qualified and 1st Lowest, as per PPRA Rules;

E. SPECIAL CONDITIONS:-

- (i) The contract will be awarded for the one year. If required, the contract will be extended mutually for period of further one year with the approval of Competent Authority, on the same terms and conditions, subject to satisfactory services;
- (ii) On award of contract, the firm shall be responsible to deliver mineral water at Parliament House, Islamabad on daily basis or as per demand of National Assembly Secretariat;
- (iii) The firm shall charge no security deposit against the empty bottles;
- (iv) On expiry of contract empty bottles shall be returned to the successful bidder;
- (v) If the contractor failed to execute order as per laid down terms conditions in the tender or the performance is not satisfactory or found to be indulging in corrupt or fraudulent practices, the action for blacklisting of firm will be taken as per PPRA Rules;
- (vi) The firm will not be allowed to sub-let the work to any other firm / person. In case of sub-letting, bid will be terminated forthwith and Security amount will be confiscated;
