

2. TERMS AND CONDITIONS

- (i) The firms should be registered with the income Tax, Sales Tax departments. The firms should quote their NTN and GST Numbers along with documentary proof. Taxes will be deducted as per Government rules.
 - (ii) The firm should quote their rates inclusive all taxes. The rates quoted shall be valid up to 30th June, 2027 and extendable for further one year with mutual consent and satisfactory performance of the firm.
 - (iii) The firm should separately quote rates for ordinary/urgent printing.
 - (iv) The firms shall submit a call deposit 5% of the bid price in favour of the National Assembly Secretariat as earnest money (refundable) failing which tender will be rejected.
