LEGISLATIVE BUSINESS

2. **MR. MURTAZA JAVED ABBASI**, Minister for Parliamentary Affairs to move that the Bill further to amend the Elections Act, 2017 [The Elections (Amendment) Bill, 2023], as passed by the National Assembly and not passed by the Senate within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution of the Islamic Republic of Pakistan.

6. **SENATOR RANA MAQBOOL AHMAD** to move that the Bill to provide for the maintenance and welfare of old parents and well-being, comfort and dignity of the senior citizens in Pakistan [The Maintenance and Welfare of Old Parents and Senior Citizens Bill, 2023], as passed by the Senate and not passed by the National Assembly within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution of the Islamic Republic of Pakistan.

13. MR. QADIR KHAN MANDOKHAIL to move that the Bill to provide for the establishment of the International Institute of Technology, Culture and Health Sciences [The International Institute of Technology, Culture and Health Sciences Bill, 2023], be passed.

14. SYED JAVED HUSNAIN to move that the Bill further to amend the Code of Civil Procedure, 1908 [The Code of Civil Procedure (Amendment) Bill, 2023], as passed by the National Assembly and not passed by the Senate within ninety days, be taken into consideration at once under clause (3) of Article 70 of the Constitution of the Islamic Republic of Pakistan.

15. SYED JAVED HUSNAIN to move that the Bill further to amend the Code of Civil Procedure, 1908 [The Code of Civil Procedure (Amendment) Bill, 2023], be passed.

16. MR. QADIR KHAN MANDOKHAIL **SYED JAVED HASNAIN,** to move that the Bill further to amend the Control of Narcotic Substances Act, 1997 [The Control of Narcotic Substances (Amendment) Bill, 2022], as passed by the National Assembly and Senate and returned by the President, be taken into consideration at once under clause (2) of Article 75 of the Constitution of the Islamic Republic of Pakistan.

17. MR. QADIR KHAN MANDOKHAIL **SYED JAVED HASNAIN** to move that the Bill further to amend the Control of Narcotic Substances Act, 1997 [The Control of Narcotic Substances (Amendment) Bill, 2022], be passed.
