NOTIFICATION

No.F.1(2)/2022-Legis.- WHEREAS, a requisition was received on 8th March, 2022 for summoning the National Assembly under clause (3) of Article 54 of the Constitution of the Islamic Republic of Pakistan.

2. WHEREAS ON 21st January, 2022, a motion was adopted by the National Assembly to allow the exclusive use of Chamber of the National Assembly for 48th Session of the Organization of Islamic Countries (OIC) Council of Foreign Ministers scheduled on 22nd-23rd March, 2022 or any other date.

3. WHEREAS, to enable the OIC for meeting, renovation work of the Chamber of the National Assembly and its Lobbies had commenced on the requirement of Ministry of Foreign Affairs by the end of February, 2022 which was under taken by the CDA.

4. WHEREAS, after receipt of requisition on 8th March, 2022 the National Assembly Secretariat requested the Senate Secretariat to provide Chamber of the Senate for holding of the National Assembly Session. The Senate Secretariat informed that the Senate Chamber is also not available being under renovation.

5. Thereafter the Chairman CDA and Deputy Commissioner, Islamabad were also approached to arrange and provide a suitable building for holding the session of the National Assembly outside the Parliament Building, at Islamabad. They have informed in writing that no suitable place is available at present in Islamabad for holding the session of the National Assembly.

6. WHEREAS, in view of the afore mentioned facts and circumstances it is evident that no suitable place would be available for holding the Session of the National Assembly till 24th March, 2022.

7. Having no adequate option available whatsoever, for holding of the Session of the National Assembly before 24th March, 2022. Therefore, in exercise of the powers conferred by clause (3) of Article 54 of the Constitution of the Islamic Republic of Pakistan read with Article 254 of the Constitution, the Hon'ble Speaker has been pleased to summon the National Assembly to meet in the Parliament House, Islamabad on the first available date i.e. **Friday, the 25th March, 2022 at 11.00 a.m.**
