MOTION FOR SUSPENSION OF MEMEBR

Mr. Speaker put the following question to the House, which was unanimously adopted by the House:-

“that during the sitting of the National Assembly today the, 22nd June, 2024, Sana Ullah Khan Mastikehl, MNA in his Budget Speech expressed highly objectionable and indecent remarks, thereby eroding and lowering the sanctity of the House, in violation of rule 30 of the Rules of Procedure and Conduct of Business in the National Assembly, 2007, disregarding the authority of Chair and abusing the Rules by willfully disrupting and obstructing the proceedings, I, therefore, name him in terms of rules 21 of the Rules of Procedure and Conduct of Business in the National Assembly, 2007. Now I put the question to the House that Sana Ullah Khan Mastikhel, MNA be suspended from the service of the Assembly for the remainder of the session.”

At 6.41 p.m., Mr. Speaker adjourned the sitting of the Assembly, to meet again on Sunday the 23rd June, 2024 at 11.00 a.m.
