RESOLUTION

The following resolution was moved by Mr. Hameed Hussain, MNA, was unanimously adopted by the House:-

"یہ ایوان 6 فروری 2026 کو اسلام آباد کے علاقے ترلائی کلاں میں جامعہ مسجد خدیجیہ الکبریٰ میں ہونے والے المناک خودکش بم دھماکے کی شدید الفاظ میں مذمت کرتا ہے، جس کے نتیجے میں معصوم نمازی شہید اور درجنوں افراد زخمی ہوئے۔ یہ ایوان دہشت گردی کے ان وحشیانہ اقدامات کو پاکستان کے آئین، مذہبی آزادی، قومی سلامتی اور بین الممالک ہم آہنگی پر براہ راست حملہ قرار دیتا ہے۔ یہ ایوان مطالبہ کرتا ہے کہ:

- اس سانحے میں ملوث خودکش حملہ آور، سہولت کاروں، منصوبہ سازوں اور سرپرست عناصر کو بے نقاب کر کے قانون کے کٹھنرے میں لایا جائے۔
- کالعدم تکفیری تنظیموں، ان کے نیٹ ورکس، فنڈنگ، سوشل میڈیا پروپیگنڈے اور عوامی سرگرمیوں کے خلاف بلا امتیاز اور فیصلہ کن کارروائی کی جائے۔
- عبادت گاہوں بالخصوص مساجد اور امام بارگاہوں کی سیکورٹی کے موثر اور مستقل انتظامات کیے جائیں۔
- شہداء کے لواحقین کو فوری مالی امداد اور زخمیوں کو بہترین طبی سہولیات فراہم کی جائیں۔
- دہشت گردی کے خلاف قومی سطح پر موثر حکمت عملی مرتب کر کے اس پر عمل درآمد یقینی بنایا جائے۔

یہ ایوان اس عزم کا اعادہ کرتا ہے کہ پاکستان میں دہشت گردی، انتہا پسندی اور نفرت پر مبنی تشدد کی کوئی گنجائش نہیں اور ریاست ہر صورت شہریوں کی جان و مال کے

تحفظ کو یقینی بنائے گی۔"
