Minister for Overseas Pakistanis and Human Resource Development (Mr. Sajid Hussain Turi); (a) Bureau of Emigration & Overseas Employment BE&OE is an attached department of this Ministry. As per provision of Emigration Ordinance, 1979 and Emigration Rules, 1979 BE&OE regulates overseas employment processes and monitor / facilitate the activities of overseas employment promoters in the country. Since April 2022 (till date), 506,247 Pakistanis citizens were registered through BE&OE for overseas employment (**Annex-I**).

(b) It is informed that from April 2022 till date, 506,247 intending emigrants were registered for overseas employment through BE&OE.

(c) Under Emigration Ordinance, 1979 and Emigration Rules, 1979 there are two modes of overseas employment i.e through Overseas Employment Promoters (OEP) and through Direct Employment Visa. During the period mentioned above, 341,786 workers are registered through OEPs and 164, 461 workers registered through Director employment. Following procedure is adopted by OEPs:—

- i. All the demands received in OEC are advertised in the press as per job description given by the employer.
- ii. After closing date of the advertisement, the foreign employers are informed about the number of applications received in response to advertisement at our offices in Islamabad, Karachi, Lahore, Peshawar & Quetta.
- iii. On receipt of interview schedule from the foreign employers' candidates are called for appearing before the foreign delegation for interview/test.
- iv. The selection of the workers for employment abroad is carried out by the foreign employers themselves with sole discretion to select the workers of their own choice from any part of the country.

v, After final selection, the selected workers are dispatched to destination countries.

(d) Following measures have been initiated to enhance the manpower export from Pakistan.

- This Ministry is in process of signing bilateral labour agreement with potential countries where Pakistani workforce may be sent for overseas employment through safe, order and regular channels i.e Germany, Romania, Portugal, Denmark, Hungary, Italy, Belgium, Iran, Libya and Lebanon.
- In addition to that, modalities in respect of sending trainee workers and skilled workers have been finalized with the Government of Japan under the MoUs signed between Government of Pakistan and Government of Japan to enable Pakistani workforce to work in Japan under two programs of Government of Japan namely TITP and SSW.
- Qatar is one preferred destination for Pakistani workforce. In this current year, more than 46000 workers proceeded to Qatar through this Ministry. Keeping in view the requirement of Pakistani workers in Qatar, this Ministry has suggested Pakistani Mission/CWA in Qatar to streamline and sensitize Qatar employers for hiring Pakistani professionals in the field of Engineering, IT and Medical to enhance the share of Pakistani workforce in Qatar labour market.
- Recently, Skill Verification Program (SVP) has been launched by Saudi authorities in Pakistan to test the skills of Pakistani workers in five (05) trades as per standards of Saudi labour market. This program was launched by Saudi Arabia under an Agreement signed between Government of Pakistan and Government of KSA to open the door of opportunities for skilled Pakistani workforce to work in mega projects of KSA *i.e.* Neom City project, Jeddah Rehabilitation project, extension of Holy Mosques etc. initiated under Saudi Vision 2030.
- MOPHRD has also taken Ministry of Human Resource Malaysia on board through High Commission of Pakistan Kuala Lumpur, Malaysia to revise the existing labour

agreement signed in 2003 between Government of Pakistan and Government of Malaysia so that manpower export from Pakistan to Malaysia may be enhanced and Pakistani workforce may be benefited to work decently.

- The efforts are underway to develop understanding between Pakistan and EU for sending Pakistani workforce in different member states of EU at all skill level. EU has launched Pak-EU Migration and Mobility Dialogue' with Pakistan which will open legal avenues for Pakistani workforce to work in EU member states.

Minister for States and Frontier Regions (Mr. Muhammad Talha Mehmood): (a) At present, there are 1,282,963 registered Afghan Refugees residing in the country validated/verified under Document Renewal & Information Verification Exercise (DRIVE). The DRIVE exercise has been extended upto December 31, 2022 for residual caseload of Afghan Refugees.

(b) Additionally, 136,490 Undocumented Members of Registered Families (UMRF) have also been documented under DRIVE

initiative whose confirmation is in process. If they are found eligible under prescribed criteria, the figure of 1,282,963 would further increase.

- (a) whether it is a fact that Pakistanis are facing multiple problems related to their visas, residences, jobs who went for work in Saudi Arabia and United Arab Emirates; and*
- (b) what steps are being taken by the Government in order to resolve the problems of the said Pakistanis?*

Minister for Overseas Pakistanis and Human Resource Development (Mr. Sajid Hussain Turi); (a) It is a fact that some Pakistani workers face problems caused by some of the foreign employers in Saudi Arabia and United Arab Emirates (UAE). However, visas are being issued by these countries to Pakistanis as per their laid down criteria and process. There is no complaint regarding issuance of visas to Pakistani workers.

The residence provided to the Pakistani emigrants are of the same standard as offered to emigrants of other labour exporting countries. Mostly, these accommodations are provided on sharing basis which are not comfortable.

The problems faced by the Pakistani emigrants in these countries usually relate to the following matters:

- (a) Violations of Foreign Service Agreement by the foreign employer;
- (b) Poor quality of food and accommodation;
- (c) Illegal deductions from salaries;
- (d) Delay in payment of salaries;
- (e) Delay in issuance of residence permits;

The companies in KSA/UAE secure jobs through licensed OEPs in Pakistan. The companies in KSA/UAE secure jobs through licensed OEPs in Pakistan. Some workers complain that their employer is not providing them job as per their agreement. The Mission examines their request and takes necessary steps as per prevailing law and negotiates their cases with the employers. If the matter is inconclusive, the mission assists the workers to file their cases in labour courts.

(b) The Government of Pakistan has taken the following steps to resolve the problems of Pakistani emigrants:—

- (a) Community Welfare Attaches (CWAs) are appointed in Pakistani Missions in the countries having large number of Pakistanis including 06 CWAs in Saudi Arabia and 03 CWA in UAE. They are maintaining close liaison with the relevant authorities of the host countries and foreign employers for resolution of the problems faced by Pakistanis. There is a well-defined mechanism in the Ministry of Overseas Pakistanis and Human Resource Development for monitoring the performance of CWAs.
- (b) In case of any complaint against a foreign employer, the relevant CWA approaches the concerned authorities in the host country. If found involved in exploitation of Pakistani emigrants, the foreign employer is blacklisted for future recruitment from Pakistan.
- (c) The complaints of Pakistani emigrants are also processed through the Bureau of Emigration and Overseas Employment (BE&OE). However, the number of complaints is very low. In case a complaint against any recruiting agency is received and if it is found involved in an illegal activity resulting in problems for emigrants, the BE&OE takes action under Emigrants Ordinance 1979 and the rules made thereunder which usually include the following:
 - i. Suspension/ cancellation of their licenses;
 - ii. Forfeiture of security amount of the license; and
 - iii. Referring the case to FIA for criminal proceedings after cancellation of the license;
- (d) Further, before granting permission to a recruiting agency for recruitment for manpower demand of a foreign employer, verification of such employer is carried out through Pakistan Missions abroad to protect the interests of Pakistani workers.

Minister for Overseas Pakistanis and Human Resource Development (Mr. Sajid Hussain Turi): (a)

- OPF Housing Scheme “OPF Valley” Zone-V, Islamabad was launched in the year 1996.

(b)

- OPF Housing Scheme “OPF Valley” Zone-V Islamabad is situated adjacent to Gulberg Housing Scheme, Islamabad. The scheme was approved by OPF Board of Governors and land measuring 4861 kanals (608 acres) was purchased/acquired during the year 1996 to 1999.
- Planning/ Designing of the scheme was carried out by M/s. NESPAK. The development works were awarded to FWO. At present, the development works of the scheme has been substantially completed. The electrification works are being carried out by IESCO (80% Completed).
- Total 2,141 residential plots were created. 1938 plots were allotted to overseas Pakistanis and 74 plots were allotted to overseas Pakistanis & non overseas Pakistanis through open auction.
- The colonization is taking place within the scheme. In order to promote colonization, OPF itself has launched the projects of “Construction of fifty (50) country home/built-up houses” and “Six (06) Apartment buildings having 120 No’s two (02) bed Apartments” within the scheme exclusively for Overseas Pakistanis.
- List of allottees alongwith amount deposited is attached at **Annex-I**.

(c) OPF has initially launched and allotted 1200 residential plots to Overseas Pakistanis in the year 1996. Later on, in the year 2008, the project of infrastructure development of the scheme was awarded to M/s. FWO. The date of commencement of the works was 8th September, 2008 and stipulated date of completion was 7th March, 2011

(30 months). OPF has granted extensions from time to time as requested by FWO mainly due to land litigations.

- At present, the development works are substantially completed. Punch list (defects) items issued by OPF consultant are required to be executed by M/s FWO, OPF has offered possession of Plots to the allottees/overseas Pakistanis and colonization is taking place within the scheme.
- The main reasons contributing to overall delay in completion of the project are as under:-
- Delay in award of development contract to M/s. FWO (Awarded in the year 2008).
- Land litigations. (407 kanals land is still under litigation).
- Delay in completion of project by M/s. FWO due to land litigations and design issued.
- Delay in completion of electrification works by IESCO.
