104. ***Ms. Saira Bano:**
(Deferred during 50th Session)

Will the Minister for Energy (Petroleum Division) be pleased to state what steps are being taken by the Government to specifically focus on those policies which have resulted in high cost of imports of Pakistan's energy products that has affected the trade balance which is further worsening and pushing the current situation of account deficit dangerously high?

Minister of State for Energy (Petroleum Division)
(Mr. Musadik Masood Malik): There are no such policies which may affect the cost of imported Petroleum Products as the Prices of Petroleum products are determined based on international prices as per approved formula by the Government.

289. ***Mr. Salahuddin:**
(Transferred from 51st Session)

Will the Minister for Human Rights be pleased to state the details of either pursuing or defending issues, complaints, representations and matters for and against Pakistan relating to human rights before any official/Non-Governmental Originations (NGOs), or forum in Pakistan and international levels during the last three years?

Minister for Human Rights (Mian Riaz Hussain Pirzada):
 Ministry of Human Rights (MoHR) defends issues, complaints and related matters on human rights through Ministry of Foreign Affairs. The

concerns are usually conveyed by United Nations, EU, and USA State Department. Some INGOs such as Amnesty International, Human Rights Watch also share their concerns against the state of Pakistan on human rights issues. Such concerns include freedom of expression, custodial torture, extra judicial killings, enforced disappearance, protection of minorities, women rights and child rights etc. Accordingly, the MoHR submits its responses through Ministry of Foreign Affairs as per given mandate under rules of business. Additionally, various UN treaty bodies communicate their observations/ recommendations as a result of review of obligatory reports submitted by Pakistan on ratified human rights conventions.

2. Besides, the Universal Periodic Review Report of Pakistan that provides a holistic overview of human rights situation, is also presented in Human Rights Council after every 4 years. Pakistan has recently defended/ presented its fourth Universal Periodic Review report in Human Rights Council on 30 January 2023. During review of Pakistan's Human Rights record, concerns shown by various states on the human rights issues, were vehemently defended by a high-level delegation of Pakistan comprising Minister of State for Foreign Affairs, Secretary Ministry of Human Rights, and representatives from Ministry of Interior and Ministry of Religious Affairs. Additionally, Government of Pakistan, submits Periodic Reports on ratified human rights conventions and optional protocols through MoFA and defended before relevant treaty bodies.

3. Lastly, Pakistan being the GSP + beneficiary regularly submits biannual implementation reports on 27 Conventions related to human rights, labour, environment, anti-narcotics and good governance to European Union through Ministry of Commerce. European Union Parliament also communicate their concerns regarding human rights issues. During last three years, they also have communicated above mentioned issues along with few individual cases which were responded in collaboration with relevant stakeholders.

290. ***Mr. Muhammad Jamal-Ud-Din:**

Will the Minister for Energy (Petroleum Division) be pleased to state:

- (a) *the date & the deadline for the completion of Iran-Pakistan Gas Pipeline at Pakistan side;*
- (b) *whether it is a fact that the Government will have to pay a fine of Rs.18 billion for failing to comply with contract/MOU of the Project;*
- (c) *whether it is further a fact that other neighboring countries have been directly enhancing trade-relations despite UNSC's;*
- (d) *if the answer to part (b) above is in affirmative, the reasons, justifications for delaying the Iran-Pakistan Gas Pipeline Project?*

Minister of State for Energy (Petroleum Division)
(Mr. Musadik Masood Malik): (a) The Iran Pakistan Gas Pipeline Project is stalled due to international sanctions on Iran. The project activities will begin once sanctions on Iran are removed and there is no threat that State Owned Entities would be hit by sanctions. Given that, no date and deadline can be given for the completion of the Iran Pakistan Gas Pipeline Project.

(b) Pakistan has issued a Force Majeure and Excusing Event notice to Iran under the Gas Sales and Purchase Agreement (GSPA), which resultantly suspends Pakistan's obligations under the GSPA. Iran, however, disputes the validity of the Force Majeure and Excusing Event notice under the GSPA. The matter will be finally settled through arbitration, should Iran takes this matter to arbitration. The exact amount of penalty, if any, is subject to the outcome of the arbitration to be determined by the arbitrators.

(c) The trade-enhancement related matter falls within the domain of Commerce Division. Petroleum Division is not aware of neighboring countries enhancing their trade-relations with Iran despite prevalent sanctions on Iran.

(d) Despite being fully committed to its contractual obligations under the GSPA, the Government of Pakistan has been unable to start construction of the pipeline due to US sanctions on Iran. The Government of Pakistan is engaged with the US authorities, through diplomatic channels, to seek exemption for the Project. All necessary actions are being taken to construct the gas pipeline at the earliest.

- (a) *the total number of Pakistani prisoners in Russia and Ukraine at present; and*
- (b) *the assistance being provided by the Government to said prisoners at present?*

Minister for Foreign Affairs (Mr. Bilawal Bhutto Zardari): (a) The total number of Pakistani prisoners in Russia and Ukraine is 10 and 06, respectively.

(b) In Russia majority of Pakistani prisoners is detained on charges of illegal migration. Pakistan Mission has taken up the matter with the concerned Russian authorities to verify their credentials and grant of consular access.

Five detainees in Ukraine are held for illegal border crossing and one is convicted on grounds of murder of a civilian and has been awarded 13 years sentence. Embassy remains in contact with Ukrainian authorities for provision of necessary assistance to Pakistani nationals including processing of their cases for early deportation.

- (a) whether it is a fact that Pakistan's Embassy in Iraq does not have an exclusive building, consequently, people at large who visit Iraq face great difficulties;*
- (b) if so, when they need to visit the embassy;*
- (c) if so, there is any proposal to establish the embassy in an exclusive building;*
- (d) if so, the details thereof; and*
- (e) if not, the reasons thereof?*

Minister for Foreign Affairs (Mr. Bilawal Bhutto Zardari): (a) The Embassy of Pakistan due to volatile security situation was closed in 2005 and reopened in May 2010 after a period of 05 years. On the recommendation of the host government the Embassy was established in hotel Al-Mansoor. Mission facilitates the Pakistani Diaspora visiting Pakistan Embassy in Baghdad and also establishes Consular Camp on regular basis in Najaf, Basra and Kurdistan Region for redressal of issues.

(b) The Embassy provides services to visitors through its existing premises.

(c) Foundation stone for the new Embassy building was laid down by Foreign Minister Bilawal Bhutto Zardari during his recent visit to Iraq (5-7 June 2023), in the extended Diplomatic Area earmarked by Iraqi Government for all Diplomatic Missions in Iraq.

(d) As noted the ground breaking ceremony was performed by our Foreign Minister along with his Iraqi counterpart in Baghdad during recent visit of the Foreign Minister (5-7 June 2023). In compliance of Foreign Minister's directives, necessary processing has been initiated towards early start of work on the project.

297. ***Sheikh Fayyaz Ud Din:**

Will the Minister for Energy (Power Division) be pleased to state:

- (a) *whether the Government is taking any steps to equip houses, factories, offices, educational institutions and bazaars/markets with solar power in the country; and*
- (b) *the number of those Government institutions which have been shifted to solar energy?*

Minister for Energy (Power Division) (Mr. Khurram Dastagir Khan): (a) Alternative Energy Development Board is proactively promoting the use and deployment of solar energy systems all across the country. The net-metering based solar installations are being promoted and facilitated in domestic, commercial, industrial and agriculture sectors. With active facilitation of AEDB, the number of net-metering based solar installations had reached up to 56,471 by April, 2023 with a cumulative capacity of 952.35 MW.

In the recently approved Federal Budget 2023- 24, all inputs for manufacturing of solar cells, batteries & inverters in Pakistan have been allowed to be imported on zero custom duty. Sales tax on solar cells, which was infused previously, was reduced to zero by present government in the Federal budget 2022-23.

In order to reduce the impact of prevailing high prices of oil and LNG in the international markets resulting in high electricity tariffs and drain of precious foreign exchange, the Government has approved the Framework Guidelines for Fast-Track Solar PV Initiatives 2022 for fast-track deployment of solar PV. These initiatives include:

- i. **Substitution of Expensive Imported Fossil Fuels with Solar PV Energy**
- ii. **Solar PV Generation on 11 kV Feeders**
- iii. **Solarization of Public Buildings**

Solarization of public sector buildings will help in meeting certain portion of electricity load through clean solar energy technology, reduce electricity bills of public offices and relieve electricity utilities/distribution companies from long-term dues. Under this initiative, building-specific Solar PV net-metering based systems will be installed

through bidding on (i) Lease Model (10-year BOOT basis); and (ii) Own-cost model. AEDB has been tasked to carry out the solarization of public buildings through competitive bidding on behalf of the public sector entities (the “Procuring Agencies (PAs)”).

(b) Under the Framework Guidelines for Fast Track Solar Initiatives 2022, the Government is targeting to solarize public sector buildings. AEDB has been tasked to carry out the solarization of public buildings through competitive bidding on behalf of the public sector entities.

Till date, AEDB has tendered **eighty-five (85)** public sector buildings for solarization all across the country upon confirmation and consent of the relevant Ministries / entities. The contracts for solarization of 02 public buildings (i.e. PM Office & PM House) have already been awarded by the relevant entities. Successful bidders for solarization of another 15 public buildings have been selected whereas evaluation of bids against the remaining public buildings are underway.

AEDB is ready to initiate tendering process for another 188 public buildings for which technical designs have been completed.

It is worth mentioning that several public entities are carrying out the solarization of buildings owned by them on their own. Moreover, the provincial governments are also carrying out solarization of public buildings at provincial level.

Minister for Energy (Power Division) (Mr. Khurram Dastagir Khan): (a) The Agriculture-I feeder was constructed in the area of District Jamshoro in the past by the HESCO. The detail is attached at **Annex-I**.

(b) In HESCO, mostly consumers of all tariffs (domestic, commercial, agriculture, industry etc.) exist in the same area, so it is difficult to separate the 11kV feeders for Agriculture and other consumers. However, at present there is no proposal under consideration for construction of separate 11kV feeders for Agriculture consumers.

(c) No proposal is under consideration.

along-with reminder dated 26-07-2023. As the requisite information is awaited, the same will be provided in the House upon receipt from the quarters concerned *i.e.* Provincial High Courts.

(**Mr. Musadik Masood Malik**): SNGPL has reported that circular debt amounting to Rs. 597,959 million (as on 24-07-2023) has been accumulated against RLNG. While no circular debt accumulated on account of the LNG charges in the books of SSGC.

304. ***Ms. Asiya Azeem:**
(*Transferred from 51st Session*)

Will the Minister for Energy (Petroleum Division) be pleased to state:

(a) *the total number of Petrol Pumps in the county and the number of staff working to maintain the quality of these pumps;*

- (b) *the number, name and details of those pumps where substandard petrol/diesel has been found during the last five years alongwith the fine imposed on those pumps; and*
- (c) *the time schedule for inspection/rechecking of the pumps is carried out?*

Minister of State for Energy (Petroleum Division)

(Mr. Musadik Masood Malik): (a) License for petrol pumps are being granted by the Explosive Department (Ministry of Energy) and as per record, there are a total of **11.102** petrol pumps of different Oil Marketing Companies (OMCs) are operational in the country. Every OMC has its own requirement for sales and quality checking staff, however, 08-10 persons are working / employed for each pump.

(b) OGRA conducts inspections on retail outlets of Oil Marketing Companies (OMCs) on random basis or on receipt of any specific complaint. The details of petrol pumps having reportedly substandard quality product inspected by OGRA in last five years is attached at **Annexure-I**.

(c) OMCs conducts their quality inspection through their mobile quality testing units on regular basis and take action against the violating outlets. However, OGRA being regulator conducts inspections of randomly selected outlets of Oil Marketing Companies (OMCs) to counter check self-monitoring system of the OMCs. Nevertheless, all OMCs are obliged to ensure quality of POL products at their respective retail outlets across the County.

Will the Minister for Energy (Power Division) be pleased to state:

- (a) what were the reasons for the recent power breakdown in the country including how much was the damage of this breakdown in rupees;*
- (b) total amount spent on its maintenance;*
- (c) whether it is a fact that an inquiry has been conducted in this regard; if so, the details thereof including the deficiencies identified in this regard;*
- (d) who is held responsible for such failure;*
- (e) whether it is also a fact that Government does not have a state-of-art system that can identify the fault first as per international standards and help in rectifying the fault as soon as possible; if so, the reasons thereof; and*
- (f) what corrective measures are being taken by the Government in this regard?*

Minister for Energy (Power Division) (Mr. Khurram Dastagir Khan): (a) As per the findings of Inquiry Committee, incident occurred at a time of lowest nationwide demand, due to stressed HVAC network connecting Southern and Northern part of the System, which caused small Signal Oscillations Stability phenomenon, leading to tripping of HVAC lines followed by tripping of HVDC line in a cascaded effect.

(b) No amount was spent on the maintenance of the system during said breakdown.

(c) Yes. The recommendations of the Inquiry Committee are attached at **Annex-I**.

In order to implement the recommendations of the Inquiry Committee, Power Division has constituted 7 sub-committees. The reports of these sub-committees, once finalized, will be placed before the Federal Cabinet.

(d) On the recommendations of the Inquiry Committee, duly approved by the Federal Cabinet, Power Division directed Board of NTDC to initiate inquiry proceedings to pin point the system operator-officers/officials responsible for the said incident and to take disciplinary action against them accordingly.

Proper protection schemes are in place in NTDC Grid System which trigger in case of faults in the system and isolates the faulty network equipment to safeguard the equipment from damage. Moreover, protection system also helps to avert the detrimental transient effect on rest of the system. It is further added that the protection system is validated from time to time by concerned formations of NTDC to ensure its healthiness.

Regarding the overall Power System monitoring by the System Operator, SCADA* system is being used at the nerve center of National Power Control Centre. Existing SCADA System has limited visibility, however, in upcoming SCADA-III project (which is under progress) its scope is being expanded to cover all Power Plants and NTDC 500 / 220kV Grid Stations. After the completion of SCADA-III Project NPCC will have to be enhanced visibility of whole power system and it will also help the NPCC to operate, monitor and control the Power System more effectively and reliably.

Besides SCADA-III, NTDC has also taken up the matter for installations WAMS** System Pilot Project. PC-I has been sent to the Planning Commission for approval and further necessary steps will be taken accordingly. This System will support NPCC control room engineers to monitor the small Signals Frequency Oscillations as well.

(f) In order to avoid such concurrence in future, Inquiry Committee has furnished recommendations in its report. For the implementation of these recommendations Power Division has constituted 7 sub-committees.

- (c) *whether the country's economy and treasury will get enlarged by acquiring these minerals?*

Minister of State for Energy (Petroleum Division)
(Mr. Musadik Masood Malik): (a) It is a fact that Pakistan is naturally blessed with reserves of various precious stones. By virtue of favorable geological environment, Khyber-Pakhtunkhwa, Gilgit-Baltistan and Azad Jammu and Kashmir (AJK) are considered as the potential gem bearing regions.

Geological Survey of Pakistan (GSP) has conducted a number of geological and geophysical surveys from time to time in the country and explored the Aquamarine, Emerald, Ruby, Tourmaline, Topaz, Quartz, Moon stone and feldspar etc.

However, the reasons for these stones not being discovered, processed and sold in international markets can be attributed to the following factors.

- (a) Pakistan's remote and mountainous regions with extreme weather conditions, where various gemstone deposits are located, often lack proper roads, electricity and other infrastructure.
- (b) Accessing international markets and establishing distribution networks for gemstones is complex and competitive. Developing reliable processing, supply chains, establishing quality assurance measures and building trust with international buyers remain challenging. The entire value chain is marred by limited identification and certification facilities and poor linkages with the domestic and international players.

(b) Discovery of precious stones requires detailed exploration for quantification and financial valuation of reserves. As briefed above, GSP has conducted a number of geological and geophysical surveys from time to time in the country and explored various precious stones. However, detailed exploration covering reserve estimation is carried out by the lease holders and respective provincial governments. The following factors are seen as impeding reserves evaluation and estimation:

- (a) Pakistan's remote and mountainous regions, where gemstone deposits are located, often lack proper roads, electricity and other infrastructure.
- (b) The exploration and mining of precious stones require substantial investment in terms of technology, equipment and expertise. Limited investment resulted in lack of systematic identification and evaluation of gemstone deposits.
- (c) The gemstone industry requires specialized knowledge and skills for extractions, cutting, processing, and marketing the gemstones.
- (d) Security, law and order issues; one of the major hurdles for attracting foreign investment.

Due to insufficient investment needed skill set, Pakistan has faced challenges in building a robust gemstone industry ecosystem requiring skilled lapidaries, gemologists and gemstone experts.

However, with the objective of enhancing the value chain productivity of gems and Jewellery (from Mine to Market), Pakistan Gems and Jewellery Development Company (PGJDC) was established in 2006 as a subsidiary of Pakistan Industrial Development Corporation (PIDC), working under the Ministry of Industries & Production, Government of Pakistan. Moreover, Trade Development Authority of Pakistan (TDAP) has been taking various initiatives and interventions for development, promotion and marketing of Gems and Jewellery across the globe.

(c) Yes. Development, processing and marketing of precision stones/ minerals can have significant contribution in the national economy/ treasury by generating revenue through mining taxes and royalties, creating employment opportunities and stimulating related industries.

308. ***Moulana Abdul Akbar Chitrali:**

(Transferred from 51st Session)

Will the Minister for Foreign Affairs be pleased to state:

Minister for Foreign Affairs (Mr. Bilawal Bhutto Zardari): (a) Total 96 Audit Paras from Audit Reports for the year 2019-2020, 2020-2021 and 2021-2022 have been considered by the. Public Accounts Committee. The work on settling these audit paras is in active progress under guidelines/monitoring of DAC and PAC. The recoverable amount pointed out by the Audit for Ministry of Foreign Affairs was Rs. 285.21 million out of which Rs. 163.579 million has been recovered / settled and work continues to recover / settle the remaining amount. Where there is

evidence of irregularity or negligence, the Ministry proceeds against such individual as required under the relevant rules and regulations.

(b) An amount of Rs. 93.286 million will be recovered / settled in due course. Majority of paras are of procedural nature like non-settlement of TA/DA bills etc.

309. ***Ms. Shams Un Nisa:**
(*Transferred from 51st Session*)

Will the Minister for Energy (Power Division) be pleased to state:

Minister for Energy (Power Division) (Mr. Khurram Dastagir Khan): (a) in order to address issues related to Energy Security, Energy mix of the country is being indigenized by the Government Hydel, Local Coal and Renewable Energy resources are being promoted.

Moreover, NPCC being the System Operator makes best possible efforts to optimally utilize the available generation resources for ensuring smooth and reliable supply of electricity in the country.

(b) The GOP, encourages establishment of power projects in public private partnership, the policy in vogue that is Power Generation Policy 2015. In line with the scope of this Policy, the incentives/ concessions available to private power; projects will also be available to projects implemented under PPP made in accordance with the applicable law.

(Mr. Musadik Masood Malik): (a) The following pipeline projects have been started by the gas utility ' companies to meet the gas requirements of the country at present.

SNGPL

- 18" dia x 230 Km from Bunnu West Well to Daudkhel Valve Assembly.
- 8" dia x 50 Km from OGDCL's processing facility to Kaka Khel Valve Assembly (Mixing Station).
- 8" dia x 16 Km from Wali Well to OGDCL's processing facility as a contract line for OGDCL.

SSGCL

- 30" diameter x 116 Km pipeline from Sindh University to SMS Pakland.
- Transmission pipeline for supply of gas to Karachi West Region.
- Execution of 8" diameters x 102 Kms Jhal Magsi gas pipeline project.
- Sibi Compressor Project.
- Installation of 01 new Compressor Unit at HQ-2 Daur, Nawabshah.

(b) In order to manage the demand supply shortfall during the winters, the government devises a comprehensive Load Management Plan

wherein uninterrupted gas supply to the top priority domestic sector is ensured during the cooking hours.

Beside the above, the Government has also taken several other mitigation measures to arrest the growth in demand as well as to improve supplies which include import of LNG, award of new blocks for oil and gas exploration, ban on expansion in domestic network and media campaigns are also being run during winters for energy conservation.

311. ***Ms. Shakila Luqman:**
(*Transferred from 51st Session*)

Will the Minister for Energy (Petroleum Division) be pleased to state:

Minister of State for Energy (Petroleum Division) (Mr. Musadik Masood Malik): (a) The indigenous gas supplies in Pakistan are depleting rapidly, whereas the demand of gas is increasing every year, thus widening the demand supply gap. At present, uninterrupted natural gas is being supplied to the existing domestic customers during the peak cooking hours.

(b) Currently, around 450 MMCFD indigenous gas is being provided to domestic customers and 1 MMCFD RLNG to the domestic customers in privately developed new housing schemes by SNGPL whereas around 368 MMCFD indigenous gas is being supplied to domestic customers by SSGCL.

However, during the winter season, the demand of domestic sector increases many folds. In order to manage the demand supply shortfall during the winters, the government devises a comprehensive Load Management Plan wherein uninterrupted gas supply to the top priority domestic sector is ensured during the cooking hours.

Beside the above, the Government has also taken several other mitigation measures to arrest the growth in demand as well as to improve supplies which include import of LNG, award of new blocks for oil and gas exploration, ban on expansion in domestic network and media campaigns are also being run during winters for energy conservation.

312. ***Ms. Mussarat Rafiq Mahesar:**
(*Transferred from 51st Session*)

Will the Minister for Human Rights be pleased to state what initiatives have been taken by the Government to address issues of gender inequality and human rights violations in the country?

Minister for Human Rights (Mian Riaz Hussain Pirzada): The Government of Pakistan is committed to ensure protection and promotion of Women Rights and to address the issue of gender inequality as well as human rights violations in the country in line with its national and international commitments. These commitments include the Constitution of Pakistan, Human Rights Core Conventions, particularly the Convention on the Elimination of All forms of Discrimination against Women (CEDAW), Sustainable Development Goals, and especially Goal 5 concerning Gender Equality.

In today's world, women's participation is phenomenal and women's active involvement and presence in all fields of life is need of the hour. Today, women occupy important positions in various fields i.e. education, health, social welfare, police, judiciary, armed forces, IT, engineering, sports, politics, media and business etc. The Government of Pakistan is fully cognizant of its responsibilities concerning women's full and effective participation and equal opportunities for leadership at all levels of decision-making. Therefore, addressing the issue of gender inequality is one of the major priorities of the Government. To effectively address this issue, specific quotas have been reserved to ensure women's participation in the Parliament as well as Government jobs.

Moreover, following the 18th Constitutional amendment, the subject of Women Development was devolved to the provinces thus mandating provinces to implement women's empowerment agenda within their respective policy and legislative framework. However, the following initiatives have been taken up by the Ministry:

- i. The Government of Pakistan has set up National Commission on the Status of Women (NCSW) with the mandate to review and assess laws, government policies, programs, measures and their implementation. The Commission has also mandate to make recommendations to achieve gender equality and women's empowerment besides the elimination of discrimination at various levels.
- ii. The Ministry of Human Rights is mandated to review the human rights situation in the country and to take initiatives including the implementation of laws, policies and measures to address human rights violations. Accordingly, MoHR through its four Regional Offices *i.e.* Lahore, Karachi, Peshawar, Quetta and its headquarter based in Islamabad monitors the human rights situation besides coordinating the implementation of laws, policies and measures with the concerned authorities. MoHR also takes up cases of human rights violations with concerned authorities for redressal, as per law. The details/ breakup of **23173** cases/ complaints/ allegations taken up during the last three years based on applications received from the aggrieved persons and cases identified through media monitoring and referred to the concerned organizations/Law Enforcement Agencies (LEAs) for redressal, as per law. Details are **Annex-I**.
- iii. Action Plan for Human Rights, approved by the Prime Minister of Pakistan is being implemented in the country by the Ministry of Human Rights in collaboration with the relevant stakeholders, through a full-fledged PSDP Project

Besides the Ministry, Toll-Free Helpline 1099, Zainab Alert Response and Recovery Agency (ZARRA) and the following Commissions are also functioning as per their mandates respectively:

- i. National Commission for Human Rights (NCHR),
- ii. National Commission on the Status of Women (NCSW),
- iii. National Commission on the Rights of Child (NCRC).

The details/breakup of **12939** cases taken up by Helpline, ZARRA, NCHR, NCSW & NCRC during the last three years is at **Annex II**.

Minister for Energy (Power Division) (Mr. Khurrum Dastagir Khan): (a) The scope of work under this project includes:

1. Construction of new 132 kV Grid Station with 01x20/26 MVA Power Transformer.
2. Construction of 132 kV associated Transmission Line in place of 33 kV system.
3. Estimated cost of the complete project i.e. 132 kV Grid Station and 132 kV Transmission Line is Rs. 752 Million.

(a) Current status for construction of 132 kV Grid Station:

Construction of the Grid Station is under process. Civil works of the Control House Building (CHB), Electrical Equipment Foundations and Residential colony has been completed. Partial material is installed except Power Transformer. The remaining material will be installed after completion of the Transmission Line which is expected to be completed by 30th June, 2024.

(b) Current status for construction of 132 kV Transmission Line:

The tender for the civil works of the 132 kV Transmission Line from Allai Power House to Thakot Grid Station with an estimated amount of Rs. 304 Million was approved by BoD PESCO. Letter of Acceptance (LOA) was issued to the contractor on 15-06-2023 for submission of 10% Performance Guarantee. The work on the Transmission Line will

commence on the issuance of work order to the Contractor on submission of 10% performance guarantee by the contractor.

(b) One month time is given to contractor for bank guarantee submission. So, Expected time for start of work is tentatively two months.

Accordingly, the Ministry of Human Rights through its four Regional Offices located at Lahore, Karachi, Peshawar, Quetta and its headquarters based at Islamabad takes up cases of human rights violations with concerned authorities for redressal, as per law. The details/breakup of **23173** cases/complaints/allegations concerning rights of marginalized and vulnerable groups in the society, taken up during the last three years based on applications received from the aggrieved persons and cases identified through media monitoring are **Annexed**. These cases were referred to the concerned organizations/Law Enforcement Agencies (LEAs) for redressal, as per law.

(b) The Government is taking appropriate legislative, programmatic and administrative measures to address human rights violation issues including issues related to gender-based violence and ensuring the safety of women and girls in the country. Action Plan for

Human Rights, approved by the Prime Minister of Pakistan is being implemented in the country by the Ministry of Human Rights in collaboration with the relevant stakeholders, through a full-fledged PSDP Project.

Besides the Ministry, Toll-Free Helpline 1099, Zainab Alert Response and Recovery Agency (ZARRA), Child Protection Institute (CPI) and the following Commissions are also functioning as per their mandates respectively:

- i. National Commission for Human Rights (NCHR),

Minister for Energy (Power Division) (Mr. Khurrum Dastagir Khan): (a) The mandate of NTDC is to install, operate and maintain 220 kV and above transmission network and it has upgraded/installed the said transmission system/network as per planning of approved projects in timely manner. The requisite details regarding the budget reserved and utilized for the transmission lines/system for last five years is given as under:

(b) i. Transmission losses of NTDC system in last 05 years have remained within permissible limits *i.e.* Less than 3% and its impact on end consumers is negligible.

- ii. Statistics of NTDC. 500 & 220kV T&T losses are regularly reported to the regulator *i.e.* NEPRA. During the last 3 years NTDC is within the allowed limit of losses. NTDC losses have gradually decreased (improved) over time. Detail is as follows:

FY 2022	2.62%	Within NEPRA allowed limits

Any losses within the allowed limit are passed on to end consumers by NEPRA accordingly as per rules.

(c) It is not a fact that NEPRA has imposed fines on non-upgradation of transmission lines rather it has imposed fines on NTDC for partial blackouts and other reasons (each is a separate proceeding for different reasons), which have been challenged as per remedies available under NEPRA Act and at law. These are sub-judice matters and will be implemented once decided.

- (d) (i) Replacement of outdated and obsolete equipment installed at Grid Stations (Transformers, Circuit Breakers, Isolators, Bus Bars, CTs, and PTs) and Transmission Lines in NTDC system to reduce system losses for providing uninterrupted and economical power / electricity to the consumers.
- (ii) Up-gradation of old type protection system with new protection schemes for enhancing reliability of the system is being carried out as per routine/ requirement.

- (a) whether it is a fact that removal of electric pole from streets is the duty of the IESCO;*
- (b) whether it is also a fact that in Village Mohra Gorya, Tehsil Gujar Khan, there is an electric pole unfortunately installed in the middle of the street and yet it has not been removed despite many requests made by Mr. Arshad Mehmood, by aforesaid resident;*
- (c) if the answers to part (a) and (b) above are in affirmative, then why the delay in removing of the electric pole and when the work will be executed?*

Minister for Energy (Power Division) (Mr. Khurram Dastagir Khan): (a) IESCO does not erect electric poles in the middle of the roads or streets. Sometimes, due to ill-planned and unpermitted construction activities by the residents, distribution facilities come to exist in the middle of roads and streets etc. IESCO can remove such poles etc. subject to payment of cost by the consumers.

(b) The LT pole erected in Village Mohra Gorya is not in center of street. IESCO does not install poles in center of streets. Due to widening of road / enhancement of street's width, consequently the poles came in the center of the road/ street.

(c) It has further been informed by SDO IESCO Operation Sub-Division, Daultala that neighbors of Mr. Arshad Melunood are not

allowing IESCO to relocate the said pole even on cost deposit basis. They have fierce enmity against each other and often lodge complaints in the police. Copy of report lodged in local police station against Mr. Arshad Mahmood is attached at Annex-A. This indicates that serious right of way issue will have to be encountered for shifting of the said pole.

IESCO cannot become a party in this dispute until and unless it is amicably resolved by both parties.

- (b) *whether it is also a fact that after sending the feasibility of work nothing has been done so far;*
- (c) *if the answer to part (a) above is in affirmative, the reasons of delay thereof; and*

Minister for Energy (Power Division) (Mr. Khurram Dastagir Khan): (a) Yes, it is a fact that Executive Engineer, IESCO, Operation Gujar Khan sent a feasibility of new electrification works to Project Director (PD) Construction, IESCO, vide Letter No. 1113-15/GKD dated

23-02-2023. This report was then forwarded to Executive Engineer (Construction) Division IESCO Jhelum for preparation of feasibility Report / Technical Data in accordance with SDI/SOP, as stated in PD (Construction) IESCO Letter No. 3820-23 Dated 08-03-2023.

(b) & (c) Yes, it is a fact that no progress has been made after sending the feasibility report. The reasons for no progress on the matter are as under:-

- i. In response to the letter mentioned in Para (a) addressed to Executive Engineer (Construction) Division Jhelum, the site was inspected and it was reported *vide* his letter No. 2501-04 dated 06-06-2023 that the **area is already electrified and it does not fall under the criteria for village electrification.**
- ii. However, a demand notice for removal of HT PC Pole No. 484 dated 24-2-2023 amounting to Rs. 1,18,104/- has already been issued to the consumer by the SDO (Operation) Sub-Division Gulyana, which has not been paid as yet. However, there is no delay on the part of IESCO as demand notice has not been paid by the complainant as yet.

(d) A demand notice has already been issued for removal of the HT PC pole and payment is still awaited from the consumer.

(e) The case is neither covered under village electrification criteria nor removal of safety hazards, accept on cost deposit basis as per NEPRA's Consumer Services Manual 2021, Chapter No. 3, Section 3.1 (RELOCATION OF DISTRIBUTION FACILITY) Sub-Section 3.1.3 **Annex-I.**

- (a) whether it is a fact that huge number of Pakistanis are detained in Saudi Arabia Jails;*
- (b) if (a) above is affirmative, the detail of each detainee with his/her particulars, nature of crime, sentence awarded, so far sentence completed, name of jail where detained;*
- (c) the steps taken by the Pakistan Embassy for early release of detained Pakistanis from Saudi jails, the detail of efforts made by the Embassy for the last five years, in response to efforts the number of prisoners released from Saudi jails (complete detail) and the names of jails from where prisoners released.*
- (d) how many Pakistanis shifted in Pakistani jails from Saudi Arabia under agreement on transfer of convicted individuals signed by Pakistan and Saudi Arabia in 2021;*

- (e) *the complete detail of staff posted in Pakistan Embassy in Saudi Arabia and its consulate offices with their names, designation posting date, tenure of posting and if any action initiated against ambassies authority on their poor performance or not meeting the target/ help assigned to them for early release of detained Pakistanis?*

Minister for Foreign Affairs (Mr. Bilawal Bhutto Zardari): (a) There are over three thousand Pakistani prisoners detained in various Jails of KSA.

(b) Information regarding prisoners detained in various Jails is being collected and will be submitted once the same is completed.

(c) The jails in Saudi Arabia house prisoners who are convicted by a court of law, after proper investigation and trial. Expatriates and Saudis are strictly dealt in accordance with law. If a detainee is proven guilty as per the rules & regulations of the Kingdom, his punishment / penalty can neither be reduced nor waived off except by a Royal decree or amnesty. No foreign Mission has the authority to influence/interfere in decisions of the courts.

As a consequence of Missions' efforts 5433 Pakistanis from central jails were released / deported while 5379 prisoners have been released/deported from detention centers from 2019 to May 2023. The Missions have also released/repatriated 250 Pakistanis after arranging payment of their fines/penalties.

(d) This agreement was signed between Pakistan and KSA in 2021 and was ratified in 2022. However, so far no transfer of the prisoners has taken place as consent of the prisoner is a pre-requisite for transfer of any prisoner to Pakistan. Prisoners prefer to stay due to better facilities in Jails in KSA.

(e) There are 16 officers and 77 officials, working in Embassy of Pakistan in Riyadh. There are 20 officers and 108 officials (Pak-based + local based staff) in Consulate General of Pakistan in Jeddah. Details are being collected.
